The Law and Justice Commission of Pakistan (LJCP) is a Federal Government institution established under the Law and Justice Commission of Pakistan Ordinance 1979, mandated for the systemic development and reform of laws, and to provide for matters connected therewith or incidental thereto, with the core statutory function to suggest legislative reforms.

The Secretariat since its inception has been working on legislative reforms and has suggested various remarkable reforms, arranging the codification and unification of laws in order to eliminate multiplicity of laws on same subjects, and removing the anomalies in the laws.


LJCP is a research organization and is also entrusted with the responsibility to introduce reforms in administration of justice. Moreover, the LJCP Secretariat works as a bridge between the executive and the judiciary in a multidimensional manner.

The Hon'ble Chief Justice of Pakistan is the Chairman of the Law and Justice Commission of Pakistan. Since, 18th January 2019, the Hon'ble Chief Justice of Pakistan, Mr. Justice Asif Saeed Khan Khosa is the Chairman of the Commission.

Police Reforms Committee meets at Islamabad to improve the effectiveness of the Criminal Justice System

The meeting of Steering Committee on Police Reforms was held on 7th January 2019 under the Chairmanship of Hon'ble Mr. Justice Asif Saeed Khan Khosa, Senior Puisne Judge, Supreme Court of Pakistan.

The Committee evaluated the status of implementation of the decisions made in its earlier meeting held in October 2018 and finalized the schedule for launching of report, "Police reforms: the way forward".

The Committee reiterated upon the need to use modern technology during investigation in criminal cases. The Hon'ble Chairman Steering Committee suggested that in order to ensure transparent and credible investigation process, we should adopt modern technological options, rather embrace technology. Further, the Hon'ble



Chairman remarked that the Committee would focus upon devising efficient, effective and transparent complaint redressal mechanism to create better image of police before the public and reduce trust deficit.



Police Reforms Committee (PRC) launches its report "Police reforms: the way forward"

The launching ceremony of the Police Reforms Committee Report was organized by the Law and Justice Commission of Pakistan on 14th January 2019 in the Auditorium of the Supreme Court of

Pakistan, Islamabad. The draft of Report was presented to Hon'ble Chief Justice of Pakistan, Mr. Justice Mian Saqib Nisar, who graced the occasion as chief guest.



During the ceremony, most of the speakers highlighted the significance of devising complaint redressal mechanism, improving quality of investigation, modernising urban policing through technology adoption and alternate dispute resolution, and appreciated the efforts of Police Reforms Committee in this context.

Hon'ble Chief Justices of the High Courts, parliamentarians, government officials, diplomatic community, members of legal fraternity, academia, local and international NGOs, media and other stakeholders of justice sector.

During the event members of the Committee



.The Hon'ble Chief Justice of Pakistan lauded the efforts of LJCP Secretariat, and appreciated Dr. Muhammad Raheem Awan, Secretary LJCP for extending secretarial support to the Committee to accomplish the assigned task. Regarding the recommendations of Report, the Chief Guest reiterated that there was high need for equipping the police with modern tools of investigation to make the process reliable, transparent and more effective to support the criminal justice system, resultantly bringing efficiency in the courts.

**The Steering Committee on Police Reforms meets to devise complaint redressal mechanism:
The Committee yearns to take measures for quality investigation**



The Secretariat of Law and Justice Commission of Pakistan arranged a meeting of “Steering Committee on Police Reforms” under the Chairmanship of the Hon'ble Mr. Justice Asif Saeed Khan Khosa, Chief Justice of Pakistan/Chairman Law and Justice Commission of Pakistan.

The Committee contemplated upon devising an effective mechanism for redressal of public complaints, innovative measures to improve quality of investigation, and to carry out a detailed data analysis to identify possible reforms in the criminal justice system. The Hon'ble Chief Justice of Pakistan reiterated upon the need to promote legal research culture to bring incremental and gradual improvements in the criminal justice system. He remarked that courts

could deliver much better through improved and effective police investigation.

The Committee desired that the Secretariat of Law and Justice Commission of Pakistan (LJCP) would compile monthly reports on Public Complaint Cells based on meaningful and relevant data for analysis and decision making at the level of the Committee.

There Committee further recommended that there should be an Assessment Committee at district level with the mandate to examine and analyse the judgments rendered in criminal cases and the bail orders to identify gaps, line of further legal research and to devise synchronised and consistent approaches at policy level in the criminal justice system in Pakistan.



The Police Reforms Committee meets to discuss future-readiness of criminal justice system in Pakistan through better policing:

The Hon'ble chief Justice of Pakistan directs to improve liaison with Judicial Academies across Pakistan for training activities to envisage coherent criminal justice system



The Committee, after thorough deliberations on the effectiveness of Public Complaints Redressal Mechanism opened discussion on improving quality of police investigation and the role of Judicial Academies in organising training activities of IOs, prosecutors and judges. The Committee also deliberated upon the proposal for organizing a National Conference on Police Investigation in collaboration with the National Police Academy (NPA) Islamabad.

The Secretary Law and Justice Commission of Pakistan, Dr Muhammad Raheem Awan and all serving Inspectors General of Police presented the data of Complaints Redressal Centers and apprised the Committee regarding the status of joint trainings of IOs, Prosecutors and Judges. Hon'ble Chairman directed the Secretary LJCP to coordinate with the Home Departments and the respective IGPs to effectively monitor the working of Complaints Redressal Centers across the country.



Supreme Court of Pakistan on 8th January 2019 which was made part of the Court order.




**Technology and Courts of the Future:
Singapore Judicial College hosts international delegates in Singapore for
the training event from 27-31 May 2019**

Singapore Judicial College (SJC) under the auspices of Singapore Cooperation Programme organised the training programme on “Technology and Courts of the Future” in the last week of May 2019 which was funded by the Ministry of Foreign Affairs, Singapore. The programme was attended by representatives of

more than 20 countries from across the world, and Mr Abdul Basit Jasra, Deputy Secretary, LJCP Secretariat participated in the programme to represent Pakistan.

Basically, the Singapore Cooperation Programme (SCP) was established in 1992 to

bring together, under one framework, the various technical assistance programmes offered by the Singapore Government.

Singapore Judicial College is a forum of judicial training that encompasses induction training, core competencies development, for example, judging, judicial ethics, case management, use of technology and judicial administration. In addition, the College focuses upon recent developments in areas of legal interest and useful interdisciplinary studies. The SJC also serves as an Empirical Judicial Research laboratory with the aim of serving as a test bed for innovation in judicial studies and practices. The SJC in collaboration with Singapore Management University has recently introduced LLM Judicial Studies especially designed for judges. This would encourage Pakistani Judicial Officers for LLM Judicial studies through scholarships to learn from the experience of Singapore Judiciary on practical fronts.

The TCOTF course incorporates the shared experiences of the Singapore Judiciary, with its ongoing modernity approaches, in

conceptualizing and implementing technology to build a future ready judicial system.

The Secretary LJCP, Dr Muhammad Raheem Awan, while discussing on the COTF concept, and the training outcomes, said that the COTF training course, being very relevant to the Pakistani context, could provide an opportunity to judicial officers, legal researchers, trainers from judicial academies and court administrators from Pakistan in learning from the experience, research and innovation of Singapore Judiciary, giving a roadmap on how Singapore has been successful in transforming its justice sector and justice service delivery.

The Secretary LJCP added that there was a dire need to improve liaison with the Singapore Judicial College, and the Singapore Cooperation Programme Directorate for arrangement of similar training events with visible participation from Pakistan. He remarked that, by using the platform of National Judicial Automation Committee and the envisaged Unit, Pakistan could achieve much on similar people-centric transformation and that the envisaged Unit could

play pivotal role in developing systems based on automation, digitalisation, data management, data analytics, and thus pave way for another success in the region. He asked the Deputy Secretary to work on it to create possibilities of enhanced cooperation between SJC and LJCP in this context.

Resultantly, the LJCP Secretariat is working on a proposal with Singapore Judicial College (SJC) for arrangement of other relevant training programmes, as per human resource requirements of Pakistan's Judiciary, under Singapore Cooperation Programme Technical Award (SCPTA) for which course fee will be borne by the Ministry of Foreign Affairs, Singapore.

Dr Muhammad Raheem Awan, Secretary LJCP expects that officers from Pakistan's Judiciary will be able to attend similar programs in future under the Singapore Cooperation Program or any other similar arrangements through collaborative partnerships. Further, he shared that the LLM Judicial Studies jointly introduced by Singapore Judicial College and the Singapore Management University is a wonderful program which is according to the professional needs of Pakistani judicial officers. He said that the SJC and SMU would hopefully encourage Pakistani Judicial Officers through scholarships for the said

program.

The meeting was organized by The Asia foundation which was held on April 1st 2019 on invitation of Chairman, International Institute for Justice Excellence, The Hague, Netherlands.

The meeting was also attended by the Hon'ble Mr. Justice Tassaduq Hussain Jilani, Former Chief Justice of Pakistan, Ad-hoc Judge International Court of Justice; Mr. Justice Anwaar-ul-Haq, Former Chief Justice, Lahore High Court; Ted Hill, Senior Legal Advisor and Head of the IDLO Hague; Leonardo D'Urso, CEO, ADR Center, Rome; Jeffrey A. He argued that the establishment of a Regional Arbitration Center for the amicable settlement of future commercial and investment disputes between member states of CPEC and One Belt One Road (OBOR) initiatives was very important and inevitable. Governing Body, Access to Justice Development Fund approves funding for Islamabad High Court and the Judicial Academies

Hon'ble Mr. Justice Mian Saqib Nisar reiterates upon organizing training activities to modernize judiciary in the age of technology and influx of e-commerce



The Chairman Governing Body, AJDF the Hon'ble Chief Justice of Pakistan stated that establishment of AJDF is a commitment of the government to strengthen the professional functionality of the Courts by improving the service delivery component and legal empowerment of the vulnerable by providing clinical legal aid and raising awareness about their rights enshrined in the Constitution.

Mr. Justice Mian Saqib Nisar, Chairman LJCP/ Chief Justice of Pakistan chaired the meetings and the following members were in attendance:

After brief discussion following decisions were made:

Share for Islamabad High Court from Judicial Development Fund Window of AJDF

The Hon'ble Chairman LJCP after seeking comments from other members approved share allocation of 5.3% of the Sub-Ordinate Courts Window for subordinate courts under Islamabad High Courts

Share allocation formula for Judicial Academies recommended by the Technical Evaluation Committee (TEC).

The Hon'ble Chairman Governing Body/ Chief Justice of Pakistan was informed by the Secretary



LJCP that on the directions of the Governing Body, proposal for an amendment in LJCP Ordinance 1979 was forwarded to the legislature which was made in 2014 to enable the provincial Judicial Academies to have share in funds allocations from the Judicial Academy Window of AJDF.

According to AJDF Rules 2002, the funding allocated for the academies would be utilized as under;

- (i) *training programs for the judiciary including mobile training arrangements and facilities;*
- (ii) *development of new courses, especially attempts at innovations;*
- (iii) *training and education for non-judicial personnel, e.g. administrators, registrars and other support staff dealing in policy development and implementation, case flow management, budget, planning, information system and record management.*

After deliberations, the Governing Body approved the proposal of the Technical Evaluation Committee for the Judicial Academies Window.

Therefore, after discussion, the Governing Body, AJDF also approved the consequential amendments in the Access to Justice Development Fund Rules 2002 and Accounting Procedures of the Access to Justice Development Fund 2005 related to amendments in the LJCP Ordinance 1979 for inclusion of Islamabad High Court and the Judicial Academies in AJDF share allocation.

Similarly, the Governing Body after reviewing funds utilization under District Legal Empowerment Committees for free legal aid, unanimously approved the formula that committees having utilized 80% of the released funding, may be provided additional funds to make the DLECs capable of provision of timely free legal aid.

Governing Body, Access to Justice Development Fund approves annual accounts of AJDF; Reviews performance and directs Secretary LJCP to assist the Courts in finalization of work plans

The meeting of Governing Body AJDF was held on 29th April 2019 and chaired by the Hon'ble Mr. Justice Asif Saeed Khan Khosa, Chief Justice

of Pakistan/ Chairman Governing Body. In addition to the members of the GB, the Senior Puisne Judge Supreme Court of Pakistan,



Hon'ble Mr. Justice Gulzar Ahmed, and other Senior Puisne Judges of all High Courts attended the meeting on special invitation.

The Governing Body considered the Accounts reflecting income, allocations and expenditure up to FY 2017-18 and after deliberations, unanimously approved the same.

Fund Utilization Status of Judicial Development Fund (JDF)

The Secretary informed the meeting that the Governing Body, AJDF in its meeting held on November 06, 2010 while reviewing the fund utilization status resolved that the next due tranche be released subject to utilization of 80% of already provided funds.

Funding to Islamabad High Court from Judicial Development Fund Window

The Governing Body was informed that after inclusion of the Islamabad High Court in Judicial Development Fund Window, the Governing Body in its meeting held on 8th January 2019, approved the revised share distribution formula whereby share equal to 5.3% of the Judicial Development Fund was approved for subordinate judiciary of the ICT.

The Secretary informed that the share allocation had been worked out and the same presented before the Governing Body for approval.

After deliberation, the Governing Body approved the share in favour of Islamabad High Court for release as per policy. The Governing Body,

however, desired that for effective and efficient utilization of funding, the Islamabad High Court would prepare expenditure plans for the prioritized areas.

Funding to Judicial Academies for training activities not covered in their regular budget.

The Secretary, Law and Justice Commission of Pakistan (LJCP) informed the meeting that the allocated share for the Federal Judicial Academy window remained unutilized till FY 2012-13 and it was decided by the Governing Body that the Provincial Judicial Academies may also be included in the Window to have funds for the activities not covered under their budgetary allocation.

The Governing Body considered the proposal and approved the share allocation for Federal and Provincial Judicial Academies for conducting activities not covered under their regular budget and allowed release of funds subject to sharing of detailed work-plans reflecting activities, estimates and timelines.
